

## **GPM Investments, LLC Monster Energy PBR Ticket Giveaway Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The GPM Investments, LLC Monster Energy PBR Ticket Giveaway ("Giveaway") is open only to legal residents of Virginia who are 18 years of age or older. The following are not eligible: officers, directors and employees of GPM Investments, LLC ("Sponsor"), Monster Energy Company, Professional Bull Riders, LLC, or any of their respective parent and subsidiary companies, and any administrative, advertising or promotional agency involved in the development, administration, promotion or implementation of the Giveaway ("Giveaway Entities"), along with members of their immediate families (spouses and/or parents children and siblings, and their spouses, regardless of where they reside) and/or persons living in the same household (whether or not related thereto).
